- **Repealing**
 - **LEOFF: WAC 415-104-211** Married LEOFF Plan 2 member's benefit selection—Spousal consent required.
 - **PERS: WAC 415-108-324** Married LEOFF Plan 2 member's benefit selection—Spousal consent required.
 - **SERS: WAC 415-110-324** Married member's benefit selection—Spousal consent required.

REASON FOR ADOPTION: Implementing Chapter 102, Laws of 2019 (HB 1408), revising the written consent requirement for survivor benefit options; and clarifying the impact to the benefit if a survivor predeceases the retiree.

HEARING: February 26, 2020

SUMMARY OF COMMENTS: No comments were received.

DIFFERENCES IN TEXT: The text being adopted is identical to the text as proposed in WSR 20-03-171, filed on January 22, 2020.
